**POLICY BULLETIN NO. 3-30**

**SUBJECT: Penalties and Service Charges**

**I. POLICY:**

The Cooperative shall impose penalties and service charges that it deems necessary on any member who fails to comply with the rules and regulations, bylaws and policies of the Cooperative. These penalties and service charges shall cover the costs involved, thereby treating all members equitably.

**II. PROCEDURE:**

- A. The Board of Directors shall review the Schedule of Fees (attached) on an annual basis.
- B. The President & CEO or his/her Delegate has the authority to waive a fee or charge at their discretion.
- C. If the member's electric service fails, he shall first endeavor to determine if he has blown fuses, tripped breakers, or his equipment is at fault before notifying the Cooperative. If a serviceman is dispatched at the member's request, and it is determined that the Cooperative's equipment is not at fault, a service charge may be rendered against the member. The service charge may be actual cost.
